Mrs. Patterson reviewed the financial statements as of July 31, 2019.

F. DISCUSSION/ACTION ITEMS

- 1. <u>Use of Excess Funds from Self-Funded Medical Plans</u>: Mrs. Patterson reviewed the excess funds remaining after the self-funded medical plan expenses had tailed out. There was extended discussion regarding use, including the importance of returning funds from the 2017-18 deficit assessment to the membership as soon as possible as well as the importance of retaining funds to buy down future rates or one-time purchases for the Health and Wellness Centers. Mrs. Patterson cautioned that buy-down of rates can cause significant increases in rates when buy-down funds were exhausted.
- 2. <u>Behavioral Health Services</u>: Mrs. Patterson reviewed behavioral health services available to the membership and noted that EAP utilization had been requested but not yet provided by SISC. Heather Dwyer, on behalf of Chris Little, commented that the current benefits were sufficient.
