1. Memorandum of Coverage, effective July 1, 2018: Mrs. Patterson reviewed the language in the current Memorandum of Liability Coverage and the referenced forms, noting that the form requiring pre-participation physical examination for athletic competition did not delineate the grades to which it applied; therefore it applied to all grades. There was discussion regarding whether that was the intent of the form or whether it should apply to grades 9-12, only. Directors indicated some district board policies required preparticipation physical examinations of all students.
